Employment of graduates	<p>Graduates of the PhD. study in Public Health Care can choose to work in one of three areas: science and research, teaching, and practice. Combinations of two or all three of these is possible.</p> <p>Among the scientific fields, it is mainly applied research where PhD. students gain further experience and skills by participating in European or domestic research and development teams. Universities are frequent employers, but increasingly research is also carried out within health care institutions or organisations that provide health-related services. Several of our PhD. students have found interesting work in hospitals and are focused, for example, on the quality of health care. Many are employed by occupational health protection organisations, health insurance companies, or pharmaceutical firms. We would like to see the state public health service provide more impetus for research, which would certainly attract more PhD. graduates.</p> <p>There are also ample opportunities in academia for assistant professorships focused on some component of public health. Even our faculty is expanding or maintaining its teaching team by selecting from among the best graduates.</p> <p>Public authorities in health care or health-related fields have also often employed our graduates. This is in part due to innovative programmes in leadership and integration with professionals that help our students gain key leadership positions both nationally and internationally.</p>
Conditions of admission	The basic condition for admission to the doctoral study programme in the full-time and part-time form of study (which end in obtaining the “PhD.” degree) is the completion of the second level of university studies. An applicant for PhD. studies must be able to demonstrate knowledge and skills at the graduate level

	<p>from master's degree study programmes in Public Health Care or Laboratory Investigation Methods in Health Care (Mgr.), or a graduate of related fields of study (MUDr., PhDr.).</p> <p>Applicants who have completed their 2nd level studies abroad must submit a ruling on the equivalence of their education.</p> <p>Another admission requirement, to ensure that applicants with the necessary abilities and aptitudes are admitted, is the admission procedure. The applicant must submit:</p> <ol style="list-style-type: none"> 1. The results of the entrance examination will be published on the faculty's website. 2. Applicants who demonstrate the highest level of aptitude for study, i.e. achieve the highest number of points, will be admitted to study. 3. An applicant who has completed higher education abroad must submit educational documents that have been officially recognized as equivalents in accordance with Act No. 422/2015 on the Recognition of Documents on Education and on the Recognition of Professional Qualifications and on Amendments to Certain Acts.

Admission procedure	<p>The admission procedure consists of:</p> <ul style="list-style-type: none"> - a written test – examination in a foreign language – the selected foreign language will be indicated by the applicant in the application (max. 60 points) - oral examination focused on knowledge that is a prerequisite for successful entry to PhD. study; the topics and categories of oral examination questions in individual disciplines are published on the faculty's website – https://fzsp.truni.sk/okruhy-otazok-na-prijimacie-pohovory (max. 60 points) - presentations and discussions regarding the proposed dissertation topic – the applicant must present his/her own dissertation proposal to the committee submitted together with the application – in a scope of from 2,000 to 3,500 words – and the committee will evaluate the quality of the developed proposal, its feasibility, choice of the research strategy, applicant's presentation of scientific and research plan, and applicant's responses to the committee's questions and suggestions. The dissertation proposal should be consulted in advance with the supervisor or a co-supervisor. A list of supervisors and co-supervisors approved by the Scientific Council of the Faculty of Health Care and Social Work of TU (FHCaSW TU) is available at the FHCaSW TU website – https://fzsp.truni.sk/zoznam-skolitelov (max. 150 points) - other documented prerequisites of scientific activity – e.g. participation in student scientific and professional activities, awards for studies, the applicant's own publishing activity, etc. (max. 30 points) <p>The maximum possible score for the admission procedure is 300 points</p>

Deadline for receipt of documents proving completion of previous education	<p>Applicants who completed their 2nd level university studies in the academic year 2023/2024 and earlier must send all the necessary attachments with their application.</p> <p>Applicants who will be completing their 2nd level university studies in the academic year 2024/2025 must submit all necessary attachments in addition to evidence of completion of the 2nd level of study – diploma, certificate of final examination, diploma supplement – according to instructions from the faculty. The faculty will send an invitation to the admissions procedure to applicants one month before the entrance examination. Applicants who will not have been issued evidence of the completion of higher education in the relevant study programme on the date of the entrance examination must later submit a</p>
