We have developed new diagnostic method for children's social and legal protection workers (CSLP), which aims to improve quality of life of children at risk of Child Abuse and Neglect Syndrome (syCAN). Thanks to rapid diagnosis, CSLP workers can identify level of risk for children in their families and specify further professional intervention more effectively. Our ambition was to teach CSLP workers not only to work with crisis intervention but also to act mainly preventively and better ensure the healthy physical, psychological and social development of children without devastating effects. Another benefit is improvement of professional competences of CSLP workers.

The development of syCAN diagnostic tool has been the focus of the research team of department's staff and Ph.D. students since 2016 [3.9]. The choice of theoretical concept of *integrated approach* (Bentowim, Gjurič, Pothe, Fuchs, Bronfenbrenner, Blumenthal and others) was result of an extensive analysis of research literature to analyse theories of the origins of violence. Integrated approach identifies causes in interconnection of ontogenetic factors, micro-meso-macrosystem factors [3.1] and [3.2], which is a particularly suitable model in social work, as it equally respects psychosocial characteristics and external environment of both the victim and the perpetrator. Thus, this approach created skeleton of our diagnostic tool, which is always composed of: (a) the manifestations and symptoms of syCAN and (b) environmental risk factors [3.3].

In addition to studying theories of emergence of violent behaviour in the individual, we also analysed the research literature to develop a list of individual symptoms of syCAN according to chosen structure of manifestations and risk factors.

Using outputs of focus groups composed of top experts working in pediatrics, psychology, and social work, we compiled thematic clusters of future questionnaire items according to the syCAN form, namely the following 4: physical abuse, psychological abuse, sexual abuse, and neglect. Thus, we created 4 separate subtests and had the children tested by selected experts.

After completed tests were returned, based on experts' crucial comments, we (1) modified test items stylistically and in terms of content, (2) reshuffled them to create 1 comprehensive test, and (3) created 4 age categories for the test.

After an extensive field test (about 200 children registered as being at risk of syCAN at the CSLP departments of the Labour Office), we conducted a factor analysis, tested reliability and validity of the test, and reduced the original 4 subtests to 3 subtests according to the age of the child (we excluded the category of children aged 0-2 years) [3.4].

With the help of CSLP staff, we tested over 300 children again using definitive formal version of test and standardised results based on the test results. Standardisation process took into account the requirements of CSLP practice. Although the test result involves a rougher estimate, it respects requirement of the Labour Office and assesses the level of risk for children in all 4 forms (physical abuse, psychological abuse, sexual abuse and neglect) in 3 ranges: mild, moderate and high risk [3.10].

The added value of the research was: (1) confronting the level of ability of CSLP workers to detect the syndrome symptoms using the test results, and (2) a crude screening of the occurrence of syCAN in the regions of Slovakia (crude because the CSLP workers were not thorough in sending completed tests). We submitted the report to the management of the Labour Office with recommendations to increase the competencies of workers. We are currently refining the results and creating finer standards based on the data obtained through licensing agreements, having provided a Czech language version of the test to the Czech partners in an ongoing project [3.10].

In 2013, at the initiative of the staff of the Directorate of Labour, Social Affairs and Family, Department of CSLP, researchers started developing methodologies that could determine the level of risk for children in their families. This led to the development of three methodologies (see Section B.5.1), which are utilised by nearly a thousand SPOD workers across Slovakia. The purpose of these methodologies is to strengthen the professional competencies of workers, particularly in the initial stages of working with clients: diagnosis and assessment. Until now, innovative and comprehensive approaches to working with families in Slovakia have aimed to improve the professional competencies of workers, enabling them to detect risks to children within families more quickly. For at-risk children, this ultimately means faster and more effective intervention, which impacts their quality of life. This shifts the prevailing focus from crisis intervention to preventive work, affecting both the quality of life of the child and the state's financial costs

Based on the cooperation agreement with the Ministry of Labour, Social Affairs, and Family of the Slovak Republic – Ref. No. 21211/2017-M\_NKSpRPNnD, Record No.: 51270/2017, concluded from December 1, 2017, to June 30, 2021, we began intensively collecting research data in 2017 for the development of two validated and standardised tests: the Rapid Test to Diagnosis CAN Syndrome and the VEGA Test to Assess Family Social Risk. Between 2021 and 2023, a total of 893 SPOD department workers from across Slovakia were trained in the administration, evaluation, and interpretation of these tests. These are the first standardised and validated tests designed primarily for social workers.

Thanks to standardised tests, workers can quantify the level of risk without the doubts they had in their subjective estimation. It is important to use this, especially with workers with no experience, but also with "burnt-out" workers. Errors in estimates are evidenced by some of the research in the aforementioned partial report, and an error rate of 30% for sexually abused children is a disastrous result( B.5.3).

Preliminary results of ongoing data collection also confirm our other assumption, i.e., that children who are drawn into a cruel divorce/separation of the parents will exhibit elevated scores for psychological abuse and also more moderate ones for neglect. If CSLP workers have test results that show signs of psychological abuse, they also have arguments against the parents, who should immediately deescalate the conflict and, if they fail to do so, immediately apply crisis intervention.

The test has been in nationwide use since 2024, and statistical data from the Central Office of Labour, Social Affairs, and Family is only available for 2023. Therefore, we are unable to quantitatively assess the effect of the test and the methodology at this time.
